

M E M O R A N D U M

Subject :- Offer of appointment to the post of LDC on fixed pay basis)

Shri Arpan Kumar Das , is hereby offered a purely temporary post of **L.D. Clerk (Group-C, UR-Category)** under the Health & Family Welfare Department, Government of Tripura for a period of 1 (one) year from the date of his/her joining the post on fixed pay basis @ **Rs.16,050/- (Rupees sixteen thousand fifty)** only (i.e. 75%) of the minimum slab of the Pay Matrix level-7 of Tripura Civil Services (Revised Pay) (1st Amendment), Rules 2018 plus additional remuneration increased by the Government from time to time with following terms & conditions.

2. The terms and conditions of appointment are as follows :-

- i. The appointment is purely on temporary basis and will not confer title to permanent employment.
- ii. The appointment may be terminated at any time by a month's notice given by either side namely, the appointee or the appointing authority, without assigning any reason. The appointing authority, however, reserves the right of terminating the service of the appointee forthwith or before the expiration of the stipulated period of notice by making payment of a sum equivalent to the salary for the period of the unexplored portion thereof.
- iii. The appointment carries the liability to serve at any part of the State of Tripura.
- iv. The appointee will have to pass a type writing test on computer (in English) at least at a speed of 30 words per minute within a period of six months from the date his/her appointment and on time scale increment will be allowed till the appointment successfully passes the type test. In case of L.D.C-Cum-Typist (Bengali), the speed should be at least 25 words per minute.
- v. The other condition of service will be governed by the relevant rules and order in force from time to time.
- vi. The appointee shall have to undergo any training if required by the Government. The service of the appointee failing of successful completion of the training even in three chances shall be liable to termination.
- vii. It may be noted that appointment shall be subject to verification of genuineness of school certificate (Admit card & Mark sheet) and genuineness of employment exchange card. The appointment will be cancelled automatically, if any document or any information produced by **Shri Arpan Kumar Das** is found **false / fake**.

3. The appointment will be further subject to :-

- i) Production of a certificate of fitness from Civil Surgeon / Medical Superintendent of District Hospital / Chief Medical Officer / Sub-Divisional Medical Officer / Government Medical Officer and any Lady Government Medical Officer (For female candidate) of Tripura.
In case of Physically Handicapped Persons such medical fitness certificate should be obtained from the Chairman Special Medical Board for Physically Handicapped persons, Government of Tripura.
- ii) Submission of enclosed attestation form duly filled in.
- iii) Submission of a declaration in the Form enclosed and in the event of the candidate having more than one wife living the appointment will be subject to his/her exemption from the operation of restriction of the recruitment in this behalf.
- iv) Taking of an oath of allegiance to the Constitution of India in the prescribed form.
- v) Government Servants joining the service of the State Government on or after **1st July 2018 shall not be governed by the existing Central Civil Services (Pension) Rules, 1972 (as adopted in the State of Tripura)** and orders issued there under from time of time. So, far as their pension and other retirement benefits are concerned, they will be governed by a new set of Pension Rules, which are being formulated in line with that Contributory Pension Scheme announced by Government of India. Submission of an undertaking in **ANNEXURE-V** enclosed regarding acceptance of new pension rules.



4. **Production of the following certificates :-**

- a) Copy of certificate of educational qualification (self attested copy).
 - b) Certificate of Character from two Gazetted Officers of the Central / State Government or stipendiary Magistrate in the enclosed form.
 - c) Certificate of age (self attested copy).
 - d) Certificate of Scheduled Caste / Scheduled Tribe in support of candidates which was issued by the competent authority (self attested copy).
 - e) Discharge certificate of previous employment, if any (self attested copy).
 - f) Certificate of PRCT from the SDM (self attested copy)/Certificate of Citizenship from District Magistrate & Collector (self attested copy).
 - g) Certificate regarding total income of the members of his/her family including his/her own from all sources, from the SDM or DM & Collector (**in original**).
 - h) Employment exchange Card (**in original**).
 - i) Copy of Ration Card including cover page (self attested copy).
5. It may be stated whether the candidate is serving or is under obligation to serve the Central Government or any other State Government or Public authority.
6. If any declaration given or information furnished by the candidate proves to be false or if the candidate is found to have willfully suppressed any material information he/she will be liable to remove from service and such other action as the Government may deem necessary.
7. He/She will not be allowed to join duties without production of *Medical Certificate* as specified in Para-3 (l) above and other documents mentioned above.
8. This offer can be cancelled at any time without assigning any reason. It will not confer any right for issuing orders for joining the post and / or formal appointment letter.
9. If, **Shri Arpan Kumar Das**, accepts the offer on the above terms and conditions, He /She should communicate acceptance by **11th December, 2023** to this office along with all required documents. If no reply is received by the prescribed date, the offer will be treated as cancelled.
10. No TA & DA will be allowed for joining the post offered to him /her.
